#### 1/5/17 Election of the chairman

3/5/17 Election of the vice chairman

Cllr F. Pickett was proposed and seconded. Council unanimously agreed. Resolved.

#### 9/5/17 To note CCTV requests

A window had been smashed at the community centre. Cllr Thompson is to attend a meeting with the police and vandals family.

Specification for the updated cameras was acknowledged. The council resolved to purchase 4 cameras at this stage.

#### 10/5/17 Playground inspection reports:

Cllr Pickett reported repairs at both parks had been completed.

The Multiplay, Mushroom and Talking Flowers have been removed from Washdyke Lane.

Dangerous trees were reported by Cllr Pickett. Council agreed to use B & J Services to clear the dead trees and foliage and make the area safe as a matter of priority.

The clerk is to remind the grass cutting contractors, Blackamore's, to include Vicarage Gardens is part of their contract.

#### 14/5/17 Highways Matters

#### 14/5/17 Planning Matters

The council supported planning applications B/17/0131 8 affordable dwellings south of Meadow Way; however comments regarding services to the properties including water, electricity and sewage were highlighted for planning officers to consider.

Council objected to B/17/0130 removal of conditions at Old Leake Caravan and Leisure Park. The council's objections remained the same as before and insisted monitoring procedures of how long people can stay and how long before they can return is not covered in the application nor is there any evidence of how this would be monitored.
