12/4/17 Planning Matters

The council supported **B/17/0317 Meadow Way** and noted the granted status of **B/17/0005** Dovecote Farm, **B/17/0052** Willow Cottage and **B/17/0063** The Sanctuary. The unfavourable decision for **B/17/0049 Meadow** View was also noted.

13/4/17 To appoint the internal auditor for the Annual Audit.

Mr Robert Smith was appointed as the internal auditor.

14/4/17 To note the date of the Annual Audit

The council noted the 6th of June as the date the parish councils completed audit needs to be at the external auditors.

15/4/17 Offer of CPR Training day with Cllr Thompson

16/4/17 To note and respond to the Old Leake Housing Paper

Council commented the sewage and water supplies would need careful consideration with regards to future development in the village. The comments about the doctors surgery being able to cope with greater demand was considered to be incorrect and the plot identified as 005 with the proposed number of dwellings listed as low density comprising of 10 houses was considered over ambitious. School Lane being unsuitable as the corner is very tight and the road would need widening.

17/4/17 To note and respond to the South Lincolnshire Local Plan

The agenda is to include the Chairman's report, financial statement, Washdyke Lane developments and a public forum.
